Historic Preservation and Rehabilitation

The Catahoula Hotel consists of two historic townhouses — a two-story structure built in approximately 1923 and a three-story brick building built in approximately 1840. Located in the Lafayette Square Historic District in downtown New Orleans, the neglected structures avoided being demolished at least twice in the 1960s and 1970s. Now it operates as the Catahoula Hotel, an upscale 35-room boutique hotel which includes a tiki rooftop terrace and a Peruvian-inspired bar and restaurant. The redeveloped hotel has been operating since 2016 and is a contributing asset in both its economic impact and historical significance.



The pair of buildings entered the National Register of Historic Places in 1991, and feature balconies recreated with the cast iron design original to the building.

All of the structure's original wood windows were salvaged and reused.
